PLEASE READ AND INITIAL EACH OF THE FOLLOWING RULES. ANY VIOLATION OF WHICH WILL CAUSE IMMEDIATE REMOVAL FROM THE PREMISES (Initial)

- 1. Smoking, drug and alcohol use is strictly prohibited.
- 2. Eye and ear protection must be worn upon entry to and at all times in range.
- 3. Eating and drinking in the range is prohibited.
- 4. Only one person may fire from the firing lane at a time.
- 5. DO NOT LOAD GUN UNTIL AT FIRING LINE & UNLOAD BEFORE LEAVING FIRING LINE
- 6. Controlled rapid fire is allowed. DEFINITION: 2-3 CONSECUTIVE SHOTS
- 7. If "cease fire" is called you are to stop shooting immediately, place firearm on bench and back away from firing line.
- 8. All firearms must be UNCASSED AT FIRING LINE & CASSED BEFORE LEAVING FIRING LINE.
- 9. DO NOT WALK AROUND RANGE WITH FIREARM IN HAND
- 10. Gun muzzles must be pointed DOWN RANGE at all times
- 11. Keep your finger off the trigger until you are ready to shoot.
- 12. Never cross the firing line.
- 13. Firearms and ammunition are subject to inspection prior to shooting.
- 14. ALL RIFLE AMMO MUST BE CHECKED BY A TOP GUN SHOOTING SPORTS INC. EMPLOYEE. NO ARMOR PIERCING, TRACER OR INCENDIARY AMMO WILL BE ALLOWED. IF CAUGHT USING UNAPPROVED AMMO YOU WILL BE CHARGED \$150 AND BE PERMANENTLY BANNED FROM THE RANGE.
- 15. Report all accidental discharges, misfires, or malfunctions at once; keep gun pointed down range.
- 16. At no time may a loaded or malfunctioned firearm (with exception for concealed firearm) leave the range.
- 17. You may keep your brass that YOU shot that day; never cross firing line to retrieve any.
- 18. Ammunition maximum muzzle velocity of 2,000 ft./ second on pistol lanes.
- 19. Clean your lane after you are finished shooting, including removing your target.
- 20. Shooters under age of 18 must be with adult supervision at all times in the range.
- 21. Range fee is non-refundable and non-transferable.
- 22. Damage to any part of range due to neglect of the customer, could result in customer paying for the damage.

\$20 fee PER HIT will be charged for shooting the ceiling deflection plates.

Applicant, for itself and its executors and assigns, releases Top Gun Shooting Sports, Inc.
